The mail transcription is bad, but understandable enough to know something is very wrong. I had no idea that it was close to the time when his children were visiting.

I call harris county 911 at 2:14pm local time and give them the phone number. I am told flat out that they can't get an address from a phone number. I hang up to try to call other family.

At 2:16pm, I get a call from my sister and Michael is conferenced in. He says it is odd and that Josh hasn't been talking about doing anything like this. Michael has his address at home.

Alina calls and is added to the conference. She is in tears and worried as hell. I ask her what Josh's address is. She says she only knows how to get there. I tell (yell at) her to hang up, call 911, and lead them over there NOW. She does, and we can only wait.

At about 3:40pm local time, I get pictures of the destroyed house.

At about 4pm local time, my sister calls and says it is on the news and that the boys were in it.

I have to say that I don't know if Josh is innocent or guilty of anything that happened to Susan. I don't know if Steve is innocent or guilty. I think Josh's final actions are the absolute most horrid thing that could ever happen; this is not a result I think any of us anticipated. I think this is not the story. The story is that there was a very positive PR campaign to search for Susan Powell that morphed into a concentrated cyberbullying campaign. We have a justice system that is supposed to put process around

determining guilt or innocence; cyberbullying follows no process or rules. It is about who is stronger, yells louder, and has more people helping it out. When I realized a cyberbullying campaign is what the "Friends and Family of Susan Powell" had become, I tried to report it to Facebook. Unfortunately, there is an automated democratic process of determining violations that appears to be triggered only after a certain threshold of complaints. Again, cyberbullying is about the strong against the weak.

I can tell you that Josh was terrorized. I'm sure there are people out there that would consider this appropriate given the mass assumption of his guilt. We all want to see criminals pay for what they have done, but when evidence lacks for due process to make this happen is this the appropriate method of alternate prosecution? This reminds me of North Korea's process – walk the accused out into a field and put a bullet in them. The difference here is that everybody spends their time enjoying the prelude as some form of sick entertainment while posting Bible scriptures to justify to themselves the reason for which they are finding so much enjoyment.

I have already forwarded to you the screen shots of the people making false CPS reports. I will compile a timeline of other information I have about the stalking and bullying. I am perfectly willing to talk to police about this, but I will insist on the press being involved for transparency. We are all outraged at what has happened, both for Josh's really abhorrent final act and for the actions of the other people involved. We can't help but wonder if this could have been prevented otherwise.

Once I determine out how to download the voice mail, I will give it to authorities as well as the press. I do not know which authorities to contact because I don't know if some of them participated in the cyberbullying campaign and quite frankly don't have a lot of trust for them.
