**ORDER**

This matter is before the Court on Appellants' requests for an expedited appeal and for emergency relief seeking a stay of enforcement of the district court's November 20, 2012, order pending resolution of the appeal of that order. The request for a stay of enforcement of the district court's order transferring custody pending disposition of the appeal is denied, and the provisional stay implemented by this Court's order of January 15, 2013, is lifted. As described below, the Court will expedite briefing and argument of the pending appeal, and the district court may make any appropriate directives to ensure that the best interests of the child are preserved until the issuance of this Court's decision.

Appellants' brief shall be filed and served on or before February 8, 2013. Appellee's brief shall be filed and served on or before March 6, 2013. Appellants' reply shall be filed and served on or before March 20, 2013. The Clerk of Court is directed to set the matter for oral argument during the period of March 26 to 28, and to promptly notify the parties of the date and time for oral argument. The Court will not accept any requests for extensions of time or for over length briefs. Pagination of the record will not be required. The parties may cite to the record in any convenient manner that clearly designates the material cited.
