

Utah State Code Regarding Legal Notices

Notice of Trustee's Sale 57-1-25. Notice of trustee's sale -- Description of property -- Time and place of sale.

(D) in a newspaper having a general circulation** in each county in which the property to be sold, or some part of the property to be sold, is situated; and...

Summons Rule 4. Process

(d)(4)(C) In any proceeding where summons is required to be published, the court shall, upon the request of the party applying for publication, designate the newspaper in which publication shall be made. **The newspaper selected shall be a newspaper of general circulation** in the county** where such publication is required to be made and shall be published in the English language.

Enforcement of Lien 38-8-3. Enforcement of lien -- Notice requirements -- Sale procedure and effect

(i) (A) if there is a newspaper of general circulation** in the county where the self-service storage facility is located, once a week for two consecutive weeks in a newspaper of general circulation in that county...

Notice to Creditors 75-3-801. Notice to creditors.

(i) once a week for three successive weeks in a newspaper of general circulation** in the county; and (ii) in accordance with Section 45-1-101 for three weeks.
